Directions

- 1 Blend all dry ingredients until product is homogenous
- 2 Dissolve 35 g of the dry blend in 235 ml of water or milk alternative and shake well
- 3 Consume within two hours

Note for production of bulk units:

Grind ERYLITE® into a fine powder by using a blender before following the directions in order to prevent segregating.
